Hon'ble Prime Minister's Office has constituted an Empowered Group on Augmenting Human Resources and Capacity Building. This group, in their meeting held on 30<sup>th</sup> March, 2020 has suggested that human resources, medical, para-medical as well as non-medical (for voluntary work) may be kept identified and trained for utilizing their services as and when required, either for treatment and management, or for surveillance or other management/ancillary works related to COVID management. Besides the doctors, nursing personnel, lab technicians, para-medical personnel, other personnel working in health facilities; the other categories of manpower that may be kept identified are as follows:

- · a. AYUSH doctors and para-medical personnel;
  - b. NCC/NSS/NYK volunteers;
  - c. Retired Army doctors;
- d. Ex-servicemen;
- e. Veterinary doctors;
- f. Red Cross, Civil Society Organizations;
- g. Gram Panchayat and Urban Local Bodies' employees:
- h. Resident Welfare Associations

2. The list of training resources as appropriate for each category has been shared earlier vide my letter of even No. dated 28<sup>th</sup> March, 2020 (copy enclosed for reference). We shall continue to update the training resources' list to include more resources and modules, as available.
