As you are aware, Nation is facing COVID-19 pandemic. The State and Central Government is taking every precaution to fight against this deadly viral infection. In Mumbai city, the outbreak of COVID-19 is spreading very fast as compared to other parts of the State. Hence the State Government has taken rigorous steps towards Prevention, Control and Treatment of COVID-19 patient.

Whereas the Government of Maharashtra, in exercise of the powers conferred under Section 2, 3, & 4 of the Epidemic Diseases Act 1897 has framed Regulations for Prevention, Control and Treatment of COVID-19 under No.corona 2020/CR/58/Aarogya-5, dated 13th March 2020.

And where as Director of Medical Education and Research, has been declared as "Empowered Officer" & is empowered to take such measures as are necessary to prevent the outbreak of COVID-19 or spread thereof within his respective jurisdiction,

I Dr. T.P. Lahane, in the larger public interest and in exercise of the powers conferred upon

me request you as follows:

"that your services are required for the prevention and treatment of COVID-19 patient atleast for 15 days. You shall therefore convey your willingness and place of choice where you would like to render your services to https://forms.gle/ucfYQB7s2pwBVDL98 within 3 days. Action will be initiated against the non-attending RMPs according to the provisions of the Epidemic Diseases Act,1897 and other Acts referred above".
