B. 1st Session by Dr. Amar Thakkar -


(1) Overview -

- Dr. Amar Thakkar initiated his webinar by thanking the platform for giving a great opportunity.
- ♠ Then he started the webinar by giving overview of his topic
 "Organon At Our Rescue in This Covid-19 Induced
 Pandemic".



(2) Explanation through Aphorisms -

- ★ The basics of the understanding was given from the base of 5th edition of Organon of Medicine, but few points were made to be noted from 6th edition of Organon of Medicine.
- ★ He shared his personal views for the consideration of aphorisms in Pandemics.
- ★ He threw light on certain aphorisms in 2 sections one mainly concerned to the classification of acute diseases & the other in relation to the case taking and points to be counted in acute cases.



• With the pointing towards the above explanation, most important aphorisms were listed down.

(3) Investigation of Epidemic & Sporadic Diseases -

♠ In relation to the classification of acute disease and for the method of investigation § - 100, 101 & 102 were explained.

(4) Part Explaining dealing with the individual cases -

- ♠ In this part sir tried to explain about treatment of acute disease with consideration of PQRS.
- In this context, § 151, 152, 153 were explained.
- With this few violent sufferings of the patient with consideration of complete picture can be treated well.

(5) Case Taking in Acute Disease -

- ★ There are points to be considered while case taking of disease of rapid course and sudden onset.
- The complete picture along with origin, duration & progress are to be considered in case-taking.
- In relation to this concept, § 92 was described.

(6) Idiosyncrasies & Peculiar Corporeal Constitutions -

- In relation to immunity and the power of the body to respond well is conceptualized in terms of idiosyncrasies.
- This concept was explained with the help of § 117.

(7) Explanation for Relapse & Palpable Aggravation -

• The concept of suppression of the acute conditions or their relapse after palliative therapy was explained with context of
§ - 59.

(8) Need of Diet & Regimen -

- ★ Lastly, the freedom of Diet & Regimen in the pandemics of such acute diseases was emphasized.
- This concept was explained with the help of § 262 & 263.


(9) Other Explanations -

- The other important aphorisms were also explained in relation to the Pandemic situation.
- ★ The aphorisms were 247, 248, 73, 272, 169 & 288 (in relation to 6th edition of Organon of Medicine).
- Moreover, § 34, 8, 4, 3, 2 & 1 were pointed out as basics.

(1) Overview -

- Starting with the definition and the § describing the concept of Symptomatology was described.

▶ Various symptoms like – Common symptom, Uncommon symptom, Pathogenic common symptom, Non-pathogenic common symptom, General symptom, Mental general, Physical general, Particular symptoms, Clinical symptoms, Basic symptoms, Determinative symptoms, Totality of symptoms, Subjective symptoms, Objective symptoms, Rare symptom, Peculiar symptom, Diagnostic symptoms, Individualizing symptom, etc. were explained.
