Madam/Sir,


As you are well aware that during last week of March 2020, the national lockdown had been declared due to the COVID-19 pandemic along with restriction of public transport and continued till end of April 2020. The countrywide lockdown has been relaxed in a phased manner from the month of May, 2020 but interstate public transport is still not fully operational.

The academic year 2020-2021 is going to commence very soon and the annual inspection/visitation is yet to be conducted. Therefore, considering the prevalent situation in the Country due to Covid-19, the Board of Governors of the Central Council of Homoeopathy recommended to exempt the physical verification of the colleges at this stage and to assess and verify the existing teaching staff, non-teaching staff, infrastructure, other training facilities and other requirements as specified in the relevant regulations and guidelines issued by the CCH and Central Government through the information submitted online in Part-1 Performa (total 17 forms) by the college/institution subject to furnishing of an affidavit/undertaking along with the Indemnity Bond. This has subsequently been approved by Ministry of AYUSH.

It is, therefore, requested you to provide the information in attached online link <https://cchforms.in/cchform/> using your teacher's code credentials (Login ID & Password) for processing your case of permission/denial, **by 20-07-2020 positively**. You are further requested to download and print all the forms before final submission (as it is required to be annexed as part of affidavit) and send immediately along with duly notarized undertaking/affidavit and indemnity bond in hard copy, so that it reaches this Council **by 27-07-2020**. The template of affidavit and indemnity bond has been provided in online form on above mentioned link.

It may be treated as most URGENT and due date may be adhered to.
