§248

- **Observation:** If the recovery ensues or the same remedy ceases to act
 - **Inference :** Repetition of same remedy
- **Observation:** If the disease is presenting different group of symptoms
 - **Inference:** A new/different homoeopathic remedy

§249

- **Observation:** New troublesome symptoms of violent character
 - **Inference:** Antidote
- **Observation:** Not of violent character of symptoms
 - **Inference:** Immediately administer a new homoeopathic remedy

§250

- **Observation:** In urgent cases, due to the wrong selection of remedy, patient conditions is worsening from hour to hour with new symptoms & sufferings
- **Inference:** Select a suitable homoeopathic remedy of the existing state of disease

§25 I

- **Observation:** Alternating action seen after administration of medicines like Ignatia, Bryonia, Rhustox ,Belladonna with no improvement
- **Inference:** Repeat the small dose of same medicine (in acute diseases- within few hours)

§252

- **Observation:** No improvement is seen after the administration of antipsoric medicine in minute dose, due to the mode of life and situation
- **Inference:** Remove the maintaining cause of disease

§253

- **Observation:** Slight aggravation or amelioration of symptoms of an acute nature, the state of mind and whole state of patient is noted

Slight amelioration- great degree of comfort, increased calmness & freedom of mind leading to the normal state

Slight aggravation- constrained, helpless, pitiable state of disposition & mind, way of behaving, all gestures, postures & actions can be seen

- **Inference:** Do not disturb the remedy

§254

- **Observation:** New or increase of symptoms; or diminution of original ones without any new ones will clear the doubt from the mind of the physician

But some patients are incapable in expressing their symptoms of aggravation & amelioration or they are unwilling to confess it

- **Inference:** So we need to ask questions one by one by comparing with the previously gained one to get a correct picture of symptoms

§255

- **Observation:** If the patient does not provide no new unusual symptoms and there is no worsening of old symptoms with improvement in the disposition & mind. The medicine selected was the positive one.

Suppose if the remedy is perfectly appropriate and it shows some delay in improvement. Then it may be due to some error in conduct on the part of the patient or the homoeopathic medicine produced in the patient is lasting too long.

§256

- **Observation:** Some fresh accidents or symptoms appear, the medicine selected is not homoeopathic, even though the patient feels better so we should not believe in this assurance
- **Inference:** It may shows the aggravation of symptoms. So we should antidote the medicine and select a new one

§257

- **Observation:** Favourite remedies; physician's experience in improvement of patients with those remedies
So he will neglect those homoeopathically suited medicines
- **Inference:** Select the homeopathically indicated one

§258

- **Observation:** Hatred remedies; neglect some medicines due to physicians bad effects or experience in such remedies so he avoid those homoeopathically appropriate one
- **Inference:** Choose the remedy based on the totality of symptoms of patients
